ORDINANCE NO. 14-1730

AN ORDINANCE TO REPEAL CITY OF MT. HEALTHY, OHIO ORDINANCE NO. 14-1726

WHEREAS, the City of Mt. Healthy, Ohio Ordinance No. 14-1726 was enacted November 4, 2014 to submit to the Hamilton County Board of Elections more than 90 days prior to the February 3rd, 2015 special election the issue of whether the Mt. Healthy Income Tax percentage levy on income shall be increased from 1.5% to 2%.

WHEREAS, the City Council desires to repeal Ordinance No. 14-1726 because the tax increase was passed at the November 4, 2014 election.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. The City of Mt. Healthy, Ohio Ordinance No. 14-1726 enacted November 4, 2014 entitled:

"AN ORDINANCE SUBMITTING AN INCOME TAX INCREASE FROM 1.5% TO 2.0% TO THE MT. HEALTHY VOTERS AND DECLARING AN EMERGENCY"

is hereby repealed.

Section 2. That this Ordinance shall be in full force and effect from and after the first date provided by law.
