## **MINUTES:**

# **CORRESPONDENCE:**

Council members on May 4<sup>th</sup> at 7:00pm the Mt. Healthy Board of Education will vote to hire Dr. Reva Closby as our next superintendent. Dr. Closby will officially begin her position as Superintendent of Mt. Healthy City Schools on July 1, 2015. There will be a "meet and greet" Dr. Closby following the board meeting.

There was a letter in council packets that was submitted to our office Friday anonymously and late today the letter came back with signatures. Typically we do not address anonymous letters. Mr. Kocher is going to follow up with Chief Demasi to see if we can talk to the person who did write the letter. The letter was regarding personnel issues and hiring process.

Mt. Healthy has already been working with ODOT for several years on Hamilton Avenue between St. Clair and Madison with a turning lane. We will reach out to NCH about this. Anytime we can do a joint project is a good thing.

## **GUESTS. SPECIAL EVENTS:**

Police Chief Vince Demasi is here with Greg Baker regarding Assumption Festival are working on a safety plan. This festival is one of the biggest in the City.

# Safety Plan Elements:

- Begin "soft" close of event at dusk or by 10:00pm
- Limit the sale of alcohol in the late night hours
- Signage on curfew requirements and expected behavior
- Fencing
- NO weapons
- No alcohol consumption outside of event area
- Event site and adjoining are monitored by camera surveillance
- Temporary lighting

#### Curfew:

- 9:00pm for juveniles 16 years of age or younger without a parent or legal guardian
- 10:00pm for 18 years of age or younger not with a parent of legal guardian
- Provide an area to detain curfew violators until parent or guardian picks up
- If parent or guardian fails to pick up the curfew violator will be cited and transported to Juvenile Detention
- Staff detention area with police and/or volunteers
- Define geographic area subject to curfew requirements

#### Communication/Public Relations

- Advertise event as fun and safe event for all
- Widely circulate information regarding curfew requirements to focus audience, specifically Mt Healthy Schools and utilize social media
- Define expected behavior
- Define consequences
- · Provide information on parking locations
- Include logos from organizations assisting in the implementation of Safety Plan: Assumption Church, Overflow ministries and MHPD

#### **Festival Event Monitors:**

- 15-20 individuals at dusk
- Provide monitors with standardized T-shirts informing as to their role and authority
- Pair monitors from Assumption and Overflow Ministries
- Stipend/donation
- Male and Female
- Training
  - Safety
  - Establish team leaders
  - o Parameters of authority and responsibility
  - Information of curfew requirements
  - How to interact with attendees
  - o Communications plan (radios and cell phones)

Let expectations be known up front will cut down on the trouble.

# **POLICE CHIEF: Vincent Demasi**

We have received a grant for body cameras. We will be using evidence.com

We ordered 10 new tasers.

We applied and were accepted in the Northeast Hamilton County Drug Task Force (DART) this will assist our community in addressing illegal drug activity. Illegal drug activity should be referred to Detective Chris Jones who will serve as our administrative liaison.

The Police Clerk position is still not filled. There have been a couple of interviews. We will post the job and continue the search.
