**A RESOLUTION TO REPEAL CITY OF MT. HEALTHY, OHIO RESOLUTION NO. 15-1076**

**WHEREAS,** the City of Mt. Healthy, Ohio Resolution No. 15-1076 was enacted July 21, 2015 to submit the question of levying additional taxes for the benefit of the City of Mt. Healthy for the purpose of providing street repair and construction to the electors of said City of Mt. Healthy at the usual voting places within said City of Mt. Healthy on the 3<sup>rd</sup> day of November, 2015.

**WHEREAS,** the City Council desires to repeal Resolution No. 15-1076 because the levy was passed at the August 4, 2015 election.

**NOW THEREFORE,** BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** The City of Mt. Healthy, Ohio Resolution No. 15-1076 enacted July 21, 2015 entitled:

"A RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MIL LIMITATION AND DECLARING AN EMERGENCY"

is hereby repealed.

**Section 2.** That this Resolution shall be in full force and effect from and after the first date provided by law.
