**ORDINANCE AUTHORIZING THE CITY MANAGER TO SIGN CONTRACTS TO PURCHASE REAL PROPERTY (HAMILTON COUNTY AUDITOR PARCEL NUMBER 593-0004-0027-00)**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** That the City Manager is hereby authorized to purchase the real property with Hamilton County Auditors parcel number 593-0004-0027-00 located at 7612 Hamilton Ave. at a price not to exceed \$100,000 and at such terms, under such conditions, and in such a manner as he shall deem to be in the best interests of the City of Mt. Healthy and;

**Section 2.** That this Ordinance shall be in full force and effect from and after the first date provided by law, and retroactive to December 1, 2015.
