**AN ORDINANCE TO REPEAL CITY OF MT. HEALTHY, OHIO ORDINANCE NO. 14-1701**

**WHEREAS,** the City of Mt. Healthy, Ohio Ordinance No. 14-1701 was enacted April 15th, 2014 to establish a Rental Permit Program for Single Family Rental units located within the City of Mt. Healthy.

**WHEREAS,** the City Council desires to repeal Ordinance No. 14-1701

**NOW THEREFORE,** BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** The City of Mt. Healthy, Ohio Ordinance No. 14-1701 enacted April 15th, 2014 entitled:

"AN ORDINANCE ESTABLISHING A RENTAL PERMIT PROGRAM FOR SINGLE FAMILY RENTAL UNITS LOCATED WITHIN THE CITY OF MT. HEALTHY"


is hereby repealed.
