ORDINANCE NO. 16-1783

**AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ACCEPT THE LOWEST AND BEST BIDS FOR THE MT. HEALTHY PARK IMPROVEMENTS PHASE V STAGE PLATFORM CANOPY PROJECT AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Mt. Healthy desires to make park improvements; and

**WHEREAS**, two separate bids were advertised, one for materials and one for installation; and

**WHEREAS**, the City of Mt. Healthy wishes to accept the lowest and best bid submitted by USA Shade & Fabric Structures on April 20, 2016 of the amount not to exceed \$64,156.39 for materials, and wishes to accept the lowest and best bid submitted by John P. Tumlin & Sons LTD on April 20, 2016 of the amount not to exceed \$23,500.00 for installation.

**NOW THEREFORE**, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** That the City Manager is hereby authorized to accept the lowest and best bid for the Mt. Healthy Park Improvements Phase V Stage Platform Canopy Project, at a cost for materials not to exceed \$64,156.39 together with the cost for installation not to exceed \$23,500.00, having a total cost not exceeding \$87,656.39.

**Section 2.** That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare and will take effect immediately upon its passage. The reason for the emergency is to begin construction at the earliest possible date.
