ORDINANCE NO. 16-1786

AN ORDINANCE TO ADVERTISE FOR BIDS AND TO APPROVE THE LOWEST AND BEST BIDDER FOR THE PERRY STREET IMPROVEMENT PROJECT, JMA #3791 AND DECLARING AN EMERGENCY

WHEREAS, the City of Mt. Healthy desires to make paving improvements; and

WHEREAS, the City of Mt. Healthy wishes to advertise for bids and enter into contract with the lowest and best bidder for the Perry Street Improvement Project, JMA #3791, not to exceed \$1,300,000.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. That the City Manager is hereby authorized to advertise for bids for the Maple Avenue Improvement Project.

Section 2. That the City Manager is hereby authorized and directed to take all necessary actions for the negotiation and creation of a construction contract with the lowest and best bidder for the Perry Street Improvement Project, JMA #3791, in an amount not to exceed \$1,300,000.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare and will take effect immediately upon its passage. The reason for the emergency is to begin construction at the earliest possible date.
