RESOLUTION NO. 110-1094

A RESOLUTION SUPPORTING ESTABLISHMENT OF A FUND FOR PURCHASING TECHNOLOGY AND THE METHOD OF COLLECTION OF SUCH FUND TO SUPPORT THE OPERATION OF THE MAYOR'S COURT CLERKS OFFICE

WHEREAS, there is a significant benefit in upgrading the electronic technology for use in the Mayor's Court Clerk's office in the City of Mt. Healthy, and

WHEREAS, the Council of the City of Mt. Healthy is in support of establishing a fund and a means of appropriating monies for such a fund.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. By order of Brian Goodyear, Magistrate of the Mt. Healthy Mayor's Court, and pursuant to the authority provided in the Ohio Revised Code, commencing August 1, 2016, an additional amount shall be added to court costs in the amount of Five Dollars (\$5.00) for each new cause of action filed.

Section 2. Said amount is to be utilized exclusively for the purchase of and/or funding of technology for the operation of the Mayor's Court Clerk's office, including, but not limited to, the purchase of computer hardware, printers, scanners, software, etc. for the operation of the Mayor's Court Clerk's office.

Section 3. Said amount shall be transmitted, according to the time prescribed by law, to the ~~City Treasurer~~ and shall be retained in an account exclusive of all other City funds.

Finance Director

Section 4. All interest income earned on the funds shall become a part of the fund.

Section 5. The funds shall be utilized, as determined by the City Council, for the operation of the Mayor's Court Clerk's office.

Section 6. That this Resolution shall be in full force and effect from and after the first date provided by law.
