ORDINANCE NO. 17-1812

AN ORDINANCE BANNING THE USE OF TOBACCO PRODUCTS OF ALL KINDS AT VARIOUS AREAS IN THE MT. HEALTHY CITY PARK AND DURING ALL PARK EVENTS

WHEREAS, The Mt. Healthy City Council recognizes that smoking is responsible for the premature deaths of many Americans each year from lung cancer, heart disease, respiratory illness; and

WHEREAS, second hand smoke is also responsible for deaths among non-smokers each year; and

WHEREAS, the Mt. Healthy City Council believes that banning the use of tobacco products in frequently used areas in the City Park and during all events in the City Park will be of benefit to the health of those using the facilities and attending events in the City Park.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. Tobacco products of all kinds shall be banned from use at the City Park Pool, Community Center Building and the Playground at all times.


Section 2. Tobacco products of all kinds shall be banned from use during all events at the City Park Gazebo, area surrounding Gazebo, Stage, area surrounding Stage, and Ball Fields including, Movies in the Park, Concerts, City sponsored events, Sporting events including games and practices and any other events where a gathering of people takes place.

Section 3. That this Ordinance shall be in full force and effect from and after the first date provided by law.

Passed this 21 day of February, 2017.


