RESOLUTION NO. 17-1101

A RESOLUTION ADVISING HAMILTON COUNTY AUDITOR OF UNNEEDED ASSESSMENT AND REQUESTING WITHDRAWAL AND DECLARING AN EMERGENCY

WHEREAS, pursuant to Ordinance 16-1793 passed September 6, 2016, an assessment on September 6, 2016 in the amount of \$134.07 was imposed on the property at 7500 Maple Ave. (parcel 593-0006-0030-00) of the Hamilton County Auditor's records for removal of high grass and weeds, and

WHEREAS, the parcel number 593-0006-0030-00 belonging to 7500 Maple Ave. was incorrectly entered as the parcel number for 1815 Compton Rd. in the assessment list in Ordinance 16-1793 passed September 6, 2016

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. The City of Mt. Healthy hereby removes the assessment made on September 6, 2016 in the amount of \$134.07 assessed to 7500 Maple Ave. (parcel 593-0006-0030-00) of the Hamilton County Auditor's records.

Section 2. A certified copy of this ordinance shall be transmitted to the Hamilton County Auditor's office at the earliest date possible.

Section 3. This resolution is declared an emergency measure for the immediate preservation of the public peace, health and safety. The reason for the emergency is that immediate passage is necessary to remove the unneeded assessment before the county property taxes are due. This ordinance shall take effect and be in force immediately upon its passage by Council and approval by the Mayor.
