**A RESOLUTION OPPOSING THE RENEWAL OF THE OHIO DEPARTMENT OF LIQUOR CONTROL LICENSE FOR THE BUSINESS LOCATED AT 7701 HAMILTON AVENUE DBA VINCE'S OTHER PLACE, 1<sup>ST</sup> FLOOR, BASEMENT, AND PATIO OWNED BY BETTY JEAN VALENTINO, AND DECLARING AN EMERGENCY**

**WHEREAS,** the Mt. Healthy Police Department has received numerous calls with complaints of disorder and illegal conduct by patrons of this establishment shown in the attached listing compiled by the Mt. Healthy Police Department; and

**WHEREAS,** these complaints involve Parking, Loud Music, Request to Assist Bar Maid, Drunkenness, Fighting, Assault, and Shots Fired, taking place on the premises; and

**WHEREAS,** such conduct caused panic and alarm to members of our community disrupting the peace and tranquility thereof.

**NOW THEREFORE,** BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** The City of Mt. Healthy hereby opposes the renewal of a liquor license to the business at 7701 Hamilton Avenue DBA Vince's Other Place, Betty Jean Valentino, owner.

**Section 2.** The Clerk of Council is hereby directed to forward a copy of this Resolution to the Ohio Department of Commerce Division of Liquor Control.

**Section 3.** This resolution is declared an emergency measure for the immediate preservation of the public peace, health and safety. The reason for the emergency is that immediate passage is necessary to present opposition to the renewal of the Ohio Department of Liquor Control permit for the premises in question. This ordinance shall take effect and be in force immediately upon its passage by Council and approval by the Mayor.
