ORDINANCE NO. 17-1834

AN ORDINANCE AUTHORIZING THE MT. HEALTHY POLICE DEPARTMENT TO DONATE NO LONGER USED AND UNCLAIMED POLICE PROPERTY TO 501(C)(3) NOT-FOR -PROFIT ORGANIZATIONS

WHEREAS, the Mt. Healthy Police Department from time to time has out-of-date and out of use materials and equipment of small value, and also unclaimed property that has come into Police custody that may be of benefit to others; and

WHEREAS, the Mt. Healthy Police Department wishes to donate these items of equipment/materials/property to worthy not-for-profit organizations for their use, with the consent of the City Manager.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. That the Mt. Healthy Police Department is hereby authorized, with the consent of the City manager, to donate out-of-date, unused, unclaimed equipment/materials/property identified as being of no use to the Police Department or City, to not-for-profit organizations as directed by the City Manager.

Section 2. That this Ordinance shall be in full force and effect from and after the first date provided by law.
