ORDINANCE NO. 18-1896

AN ORDINANCE AMENDING SECTION 34.21 OF THE MT. HEALTHY OHIO CODE OF ORDINANCES

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. That Section 34.21 subsection (A) of the Code of Ordinances of Mt. Healthy, Ohio is hereby amended to read as follows:

Section 34.21 ORGANIZATION OF OFFICERS AND DEPARTMENT

(A) The Police Department for the city shall be organized and consist of the following officers as determined by the City Manager and approved by Council:

- (1) A Chief of Police
- (2) Three police sergeants
- (3) No more than twelve (12) full-time patrol officers.

(B) The number of part-time officers and the need for the same shall be determined by the Mayor.

Section 2, That existing section 34.21 of the Code of Ordinances of Mt. Healthy, Ohio is hereby repealed.

Section 3, That this Ordinance shall be in full force and effect from and after the first date provided by law.
