ORDINANCE NO. 18-1063

AN ORDINANCE AMENDING CHAPTER 50.99 OF THE CITY OF MT. HEALTHY CODE OF ORDINANCES

WHEREAS, Section 50.99 of the Codified Ordinances authorizes the city to impose a penalty for violating Sections 50.01 through 50.06 of the City of Mt. Healthy Code of Ordinances regarding Solid Waste, and

WHEREAS, Clarification is needed to direct the proper City Department in enforcing these Codes.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. That Chapter 50.99 is hereby amended to read as follows.

§ 50.99 PENALTY.

(A) Whoever violates any of the provisions of § 50.01 through 50.06 inclusive shall be guilty of a misdemeanor and punished by a fine of not more than \$50. Each day that a condition which violates any of the foregoing sections exists is a separate violation.

(B) Whoever violates § 50.07 shall be subject to the penalty provisions of § 10.99.

(C) In addition to any law enforcement/police officer of the City, a representative of the Mt. Healthy Property Maintenance Department is authorized to issue a citation for violations of the provisions of Section 50.01 to 50.06 of the Mt. Healthy Municipal Code.

Section 2. That this Ordinance shall be in full force and effect from and after the first date provided by law.
