Public Input Regarding Group Home at 1941 Compton Road

Robin Meredith;

Worries about the crime and trouble that it may bring to the neighborhood. This is a for profit group home and after looking into it the wages are low for these types of homes, so how invested will these 24/7 staff members be to keeping peace with these boys.

Bruce Henderson – Owner of Keys to Life Group Home program.

- He has been doing this for 12-13 years
- Staff wages will be \$13-14/hour
- He did not get in the business for the money
- Always going to be compliant based on the number of boys allowed in the home
- The staff turnover is not much at all at their other homes they run
- This is a non contact group home. The staff will not put their hands on these kids. They are trained to deal with issues other ways to calm the situation down
- These are foster kids that need love just like all other children.
- The state will be the one to recommend the boys to this home.

These types of group homes are allowed at this location. This is a conditional use permit that council will be voting on. The planning commission recommended it be allowed with several conditions that must be met. This conditional use permit will only stay with this group home owner.

A motion to waive the two-reading rule was made by Mrs. Moody and seconded by Mr. Parsons. A roll call vote carried the motion 6-0. A motion to adopt the ordinance was made by Mr. Roetting and seconded by Mr. Parsons. A roll call vote carried the motion 7-0.

OLD BUSINESS:

Park/Lynndale street project not has a first coat of blacktop. The final coat will be put down in the spring.

South Perry is trying to get a base coat put down before the asphalt plants close for the winter. The final coat will be put down in the spring.

Hamilton Avenue will be getting new waterlines put down. They have already started north of Adams. They will continue their work from Adams to Kemper. Not sure when this will start.
