RESOLUTION NO. 19-1132

A RESOLUTION ADVISING HAMILTON COUNTY AUDITOR OF UNNEEDED ASSESSMENT AND REQUESTING WITHDRAWAL AND DECLARING AN EMERGENCY

WHEREAS, pursuant to Ordinance 17-1835 passed December 5, 2017, an assessment on December 5, 2017 in the amount of \$500.00 was imposed on the property at 2068 Lexa Court (parcel 593-0012-0007-00) of the Hamilton County Auditor's records for costs of the vacant foreclosed property registration fees, and

WHEREAS, the parcel number 593-0012-0007-00 belonging to 2068 Lexa Court was dropped from being foreclosed on by the mortgage lender in November, 2017.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. The City of Mt. Healthy hereby removes the assessment made on December 5, 2017 in the amount of \$500.00 assessed to 2068 Lexa Court (parcel 593-0012-0007-00) of the Hamilton County Auditor's records.

Section 2. A certified copy of this resolution shall be transmitted to the Hamilton County Auditor's office at the earliest date possible.

Section 3. This resolution is declared an emergency measure for the immediate preservation of the public peace, health and safety. The reason for the emergency is that immediate passage is necessary to remove the unneeded assessment before the county property taxes are due. This ordinance shall take effect and be in force immediately upon its passage by Council and approval by the Mayor.
