ORDINANCE NO. 20-1909

AN ORDINANCE TO AMEND SECTION 95.64 OF THE MT. HEALTHY MUNICIPAL CODE OF ORDINANCES TO INCLUDE AN ADMINISTRATION FEE IN ADDITION TO THE COST FOR THE REMOVAL OF HIGH GRASS, WEEDS AND LITTER

WHEREAS, the Mt. Healthy City Council has identified the need to include an Administration Fee in addition to the cost for removal of high grass, weeds and litter.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. Section 95.64 of the Mt. Healthy Municipal Code of Ordinances is hereby amended to read as follows:

§ 95.64 WRITTEN RETURN TO COUNTY AUDITOR; AMOUNT AS A LIEN UPON PROPERTY

The Legislative Authority shall make a written return to the County Auditor of their action under §§ 95.61, 95.62, and 95.63, with a statement of the charges for their services, the amount paid for labor, the fees of the officers serving the notices, an administrative fee, if any, charged by the Legislative Authority not to exceed Two Hundred Dollars (\$200.00) and a proper description of the premises. These amounts, when allowed, shall be entered upon the tax duplicate and be a lien upon such lands from and after the date of entry and be collected as other taxes and returned to the municipality with the general fund.

Section 2. That this Ordinance shall be in full force and effect from and after the first date provided by law.
